INDEPENDENT POST-ELECTION WRAP UP: WHO WON, WHO LOST, WHO'S GROWING.

IndependentVoting.org President Jackie Salit spoke with over 150 independents from around the country on her national conference call entitled **Independent Post-Election Wrap-up: Who Won, Who Lost, Who's Growing** last week:

"No matter who we vote for, no matter who comes out the winner in any particular election cycle, no matter how much we vote for change, everything pretty much stays the same," said Salit. "What are we going to do about the fact that we are trapped in a self-perpetuating system of enduring partisanship, intractable gridlock and political narrow-mindedness? Surely getting out of that trap involves some systemic changes. Otherwise the system will ensure that things simply don't change."



Salit ended with an appeal to those on the call:

"There are millions of independents in this country—actually tens of millions. They are, for the most part, disaffected, distressed and disillusioned. We gotta go find them. We gotta go talk to them. We must inspire them. We must let them know there are independent leaders such as yourselves, that are fighting for them, and that we want to get them out of their disillusionment and distress and have them help us build our movement."

INDEPENDENT VOTER GROUPS FILE AMICUS BRIEF IN NEW JERSEY CLOSED PRIMARY CASE

A number of state organizations representing independent voters submitted an Amicus Brief in support of EndPartisanship.org's [appeal with the U.S. Third Circuit Court of Appeals](#). The Appeal, which was filed in Philadelphia on November 3, maintains that the current primary system denies 47% of the electorate meaningful access to the voting process. The **Amicus Brief** was co-authored by Independent Ohio leader and Attorney Rick Robol and Virginia Independent Voters Association (VIVA) chair Steve Richardson, and was filed by Robol on behalf of the Massachusetts Coalition of Independent Voters, Independent Pennsylvanians, North Carolina Independents, the Utah League of Independent Voters, Independent Ohio and VIVA. It urges the court to reverse the original decision of the New Jersey federal district court that dismissed the case.
