## Activists Report on National Conference Call

Independent Voting President Jackie Salit interviewed independent voter activists from Florida, New Hampshire, Indiana and Illinois on **her last national conference call** joined by 185 independents. Each interview teased out answers to the questions sent in this month.

Salit underscored four basic themes that most of the questions she received addressed:

- How can independents get recognition as independents?
- How do we make ourselves more visible as independents?
- How do we hold the parties accountable for their exclusionary and partisan practices?
- How do we think about our future, including a strategy for 2020?



"*The answers live,*" she said "*not in the abstract, but in the actual work our networks are engaged in.*"



Q. What can people learn from your experience? (Salit asked **Steve Hough**, lead spokesperson for Florida Fair and Open Primaries in reference to the campaign he has been leading in Florida to influence the State Constitutional Revision Committee to put a top two nonpartisan primary before the voters).

A. Growing up, I was always an introvert. When I first got involved, I said: "Can I do this? Can I go up to someone and ask them how do you feel about the primaries?" Once you start doing it, it almost becomes natural. You're talking about something that you are passionate about, you firmly believe in and it just gets easier each time you do it.

**Juli Dominguez**, co-founder of Independent Voices of Indiana and a leader in the local campaign for Bernie Sanders, discussed the dialogue taking place among activists who supported Sanders about where to best focus their organizing efforts. Juli shared her experience of attending the national conference of independents and returning to Indiana to speak with Sanders supporters about it and the independent movement.

**Jarell Corley** spoke about why he has decided to form a group of independents in Chicago. "I decided it's not about the end goal, but the progression along the way. I want to have a meeting and let people know there are people here to connect with." Corley will be holding his first meeting in August.

**Tiani Coleman**, President of New Hampshire Independent Voters, reported on her attendance at a meeting of the Democratic Party Unity Reform Commission which was formed at the DP convention as a result of the contentious primary between Clinton and Sanders. Salit asked Coleman about the legal suit brought by a number of Sanders supporters in which the party has made it clear that while they might make some changes because they lost the election, they have the authority to keep their primaries closed.

## Will of the Voters in Jeopardy in Colorado

After the Colorado state legislature got its partisan paws on the newly passed voter initiative for open primaries, independents sent a letter to the Governor asking him to veto their amended bill. The bill required public disclosure of which party's ballots unaffiliated voters choose in the now opened primaries. Propositions 107 and 108, which the voters passed in November, established an open presidential primary as a matter of law and guaranteed that no voter be required to join a political party as a condition of voting in any election.



In a letter to the Governor, **Gwen Ballard**, founder of Coalition of Independent Voters in Colorado (CIVIC), along with Independent Voting President Jackie Salit wrote:

*"If Senate Bill 17-305 is signed into law, unaffiliated voters will have to "pay a price" for entry: they will forfeit the privacy of their choice of ballot and subject themselves to having their voting data mined by the parties....The entire reason for Proposition 108 was to give unaffiliated voters the proper standing in primary elections, not to tee them up to be converted, absorbed or recruited, at taxpayer expense, by the Democratic or Republican parties."*

The Governor went ahead and signed the bill into law prompting independents to begin exploring their options. Reporter Luke Perkins of the *Durango Herald* interviewed Gwen Ballard about the story. He wrote:

*"One option is a referred petition that would take the implementation of SB 305 to a vote of the people, but that might be out of reach." Ballard continued, "We'd have to get something in excess of 90,000 signatures here in the next two months." Ballard added that if a petition did make the ballot, she believed Coloradans would reverse the actions of the Legislature.*

"We are very convinced if this were put to a vote of the people of Colorado, it would pass by a large margin," she said.

## Primaries, Partisanship, Participation!

Primaries, Partisanship, Participation, was the rallying cry of Independent Pennsylvanians on Primary Day, May 16.

In an email to their membership, leaders of the group asked for help fighting for a fair and open election system by writing a letter to local news editors in protest of Pennsylvania's undemocratic closed primary system.

*"Independents help pay for the Primaries, but we can't vote in what is essentially the first round of elections. Make your voice heard with your local media outlets."* The group also asked supporters to take a picture holding a sign saying I CAN'T VOTE TODAY. ASK ME WHY? Post it on Facebook and other social media outlets to generate public awareness and conversation.





The former editor of the *Philadelphia Inquirer*, Chris Satullo, added his own voice to the call for open primaries with [his column](#), "Let's Experiment with Open Primaries in Philadelphia." Independent **Hugh Campbell** backed him up in a letter to the editor ("[Antidote for Gridlock, Voter Apathy](#)") and raised an important cultural issue -- that closed primaries engender "learned helplessness" among voters.

In New Jersey, also a closed primary state, independents are organizing a Statewide Independent Exit Poll for Tuesday, June 6th. Currently, 48% of the voters are independent, making it the largest bloc of voters in the state. Like Pennsylvania, New Jersey is electing its governor this year. In addition, the entire New Jersey legislature is up for re-election.

The New Jersey poll is designed to learn more about how primary voters feel about opening up the political process, the choices they have on the ballot and how they feel about their tax dollars being used to pay for a primary that excludes 48% of New Jersey citizens. 


