Florida Supreme Court Rules "All Voters Vote" Initiative on the Ballot in November

Great news! The voters of Florida will have their say!

Last week, the Florida Supreme Court ruled
Amendment 3, the All Voters Vote open primaries
initiative, constitutional and certified it for the
November 2020 ballot.

The All Voters Vote initiative would establish a top two nonpartisan primary system in Florida. It puts these questions before the voters: Should political parties control the electoral process, and should all voters have equal voting rights?



Said Steve Hough, Director of Florida Fair and Open Primaries, which helped lay the groundwork for the initiative:

"All Voters Vote collected 1.2 million signatures and has satisfied the constitutional requirements necessary to put the proposal before voters in November. Although the state Attorney General and both major parties filed briefs with the court in an attempt to stop the proposed amendment from moving forward, the Florida Supreme Court found their objections were without merit. As someone who has been working for years to open Florida's primaries to independent voters, I'm ecstatic that the fate of the proposed amendment now rests in the hands of the voters, not party leaders."

Congratulations Steve Hough, Florida Fair and Open Primaries and the All Voters Vote team! This is an important step forward for the voters of Florida, for the country and all who believe that a functioning democracy is more important than ever.

Independents Protest Closed Primaries at the Polls

Amid the growing political and health crisis, local independent leaders made their claim on democracy by organizing protest actions on Primary Day (March 17) in Arizona (Mesa, Prescott , Peoria and Tucson) and Florida (Panama City, Land O'Lakes, New Port Richey, Dade City, and Winter Park). These are two states that held presidential primary contests that excluded independent voters. In Florida, activists also educated voters about Amendment 3.

Steve Hough recorded several statements from independents who were unable to vote as he set up shop 150 feet from the Bay County Supervisor of Elections office. Here's one from Alex, a young woman who talks about how she was barred from participating in the primary election.

In Arizona, protest participants had signs like "I Can't Vote Today; Ask Me Why," and an article written by Independent Voters for Arizona leader Al Bell, titled "Voting if You Can in the 21st Century," published last week in *The Arizona Capitol Times*.



The Fight for Open Primaries in Missouri

HB 1639, a bill introduced by Rep. Jered Taylor (R), is making its way through the Missouri legislature. This bill would force voters to register into a party 23 weeks before the primaries and close the primaries to any voter who did not pick a party. Even though Missourian taxpayer dollars pay for the elections, hundreds of thousands of voters would be excluded from participating.

Open Primaries and the The People are conducting a campaign to stop the bill. Open Primaries is circulating an online petition to the Rules Committee that hundreds of Missouri voters have signed. The People is working with Missourians across the state to write letters to the editor for their local newspapers, and to send postcards to the Rules Committee in advance of their return to the Capitol at the end of the month.

Independent Voting has joined the effort with a volunteer team of activists who are calling into districts where members of the Rules Committee live. If you would like to join this volunteer team, email **Gwen Mandell**.

Meanwhile, **St. Louis Approves** is spearheading an effort to adopt Proposition D, which would establish an open, non-partisan system for elections to citywide offices. The initiative combines nonpartisan voting with approval voting. St. Louis, a majority Black city, is one of the few major cities that does not have a nonpartisan system of governance.

View the video below for an endorsement by David Cherry, Independent Voting board member, Chicago's City Leader of the All Stars Project, and President of the Leaders Network, a body of prominent faith and community leaders working together for social justice in Greater Chicago.

In the video, Cherry strongly disagrees with the idea (promoted by certain political party leaders) that the African American community has no stake in reforming the party system.

"The Black community has always been in the forefront of the fight for democracy," said Cherry.



Politics and the Pandemic: Watch The Political Vigilante

Lance Morris, Wolf Point, Montana

My name is Lance Morris. I am Yankton Dakota and Wadopana Nakoda born on the Assiniboine & Sioux Reservation in NE Montana. My Dakota Name is Wahukaza. My Dakota Name is Fighting Grizzly Bear Spirit. I went to one of the Bureau of Indian Affairs boarding schools in Nevada. Then to Haskell Indian Nations College. I am an independent activist.



Lance Morris, MT

Many of my people are Democrat, and about 25 percent are Republican. I will not belong to a political party. Being an independent voter gives me freedom to choose. Indigenous People and Nations suffer from historical trauma caused by hundreds of years of war with European and then colonial invasions of Indigenous territories and the extermination of over 60 Indigenous Nations. In the 1800s, Democrats forged the policies of Indigenous removal from ancient homelands and when the Republican party took power for the first time they hung 38 Sioux warriors in Minnesota. To list atrocities by both political parties inflicted on Indigenous People and Nations would take too long.

Both political parties will not admit guilt or apologize for their part in what was done to the First People of America.

I will not belong to the political parties with Indigenous blood on their hands that hasn't

been answered for.

I believe that independent voters are free thinkers. I believe they are fair and support Indigenous issues. Today's political climate must change and independent voters will make the difference. For unity and healing, we need to walk forward together as a Nation.

The U.S. Court of Appeals for the D.C. Circuit heard oral arguments Feb. 24 in Level the Playing Field v. FEC - a lawsuit that the advocacy group filed in 2015 along with its CEO, Peter Ackerman, and the national Green and Libertarian Parties.
