Independent Voting Vice President for Natioonal Development Cathy Stewart and Independent Voting advocate Amikka Burl hosted a fast-moving and entertaining show featuring activists and actors of the burgeoning independent movement. Awards were presented honoring Farhad Mohit, Gaby Cardenas

and Katherine M. Gehl, three innovators who recognize the importance of the independent voter community and the need to revitalize American democracy.


As Independent Voting President Jackie Salit said in her comments, "This is not a movement that someone thought up in a board room or a think-tank or a university somewhere. This is a movement that's being co-created at many different levels of society, by many different types of people. It's a movement with a vision that can move our country forward — inclusive democracy, inclusive development and a vision for the country that makes the lives of every person, every community, and every family, better."

The event, in addition to being a spirit-raiser, was also a fundraiser. Viewers donated and watched the event "fund-a-meter" steadily rise. The financial goal was reached -- \$100,000 was raised to invest in outreach to connect, train, and empower independent voters.

# **Andrew Yang Criticizes Two-Party System**

In this *CBS News* interview, Andrew Yang talks about why he left the Democratic Party to become an independent. Yang has formed The Forward Party, which is open to all, regardless of how you are registered or how you identify, and has been advocating publicly for open primaries and other political reforms.



"We can all just look around and see the duopoly is not working," Yang told *CBSN* "Red & Blue" anchor Elaine Quijano in an interview that aired November 8. "The political incentives are not around getting anything done, it's around blaming the other side, and just playing 'you lose, I lose' back and forth — while the people are losing."

## **Profiles in Independence**

Today, many would say that the American experiment has failed. They would say that despite all the lives that had been sacrificed to preserve freedom, power-hungry politicians have succeeded in turning America into a Tyranny. They may be right, but as an individual who served for 30 years in the defense of freedom as a US Naval Officer and never lost sight of the fundamental principle of freedom, I am certain that there is still hope for the world if we as independent people come together and stand on the common ground we know as freedom.

Unfortunately, the members of the two primary political parties have made it nearly impossible for individual citizens to be proactive and interdependent. Each time a power over the people switches from one party to the other, the government increases the number, style, and complexity of the law. This provides them with greater potential to use force to further restrict our freedoms and to control the outcome of elections. At the same time, they pit us against each other and skillfully use us as ideological soldiers in their armies.

We are tricked into believing that those who get elected are actually in charge. They are not; they are *charged* and polarized but they are not *in charge*. They are used to charge the rest of us by making us believe that "our side" is all positive and the "other side" is all negative. By reflecting on our true selves we will see that there is positive and negative in both sides of every issue and if we focus on the principle of freedom, we can declare our independence, we can think win/win, seek first to understand others and then to be understood, and synergize to achieve the public victory that our founders envisioned.
